

◇ **148 PC Resist, Obstruct, Delay of Peace Officer or EMT.**

(a) Every person who willfully resists, delays, or obstructs any public officer, peace officer or an emergency medical technician, as defined in Division 2.5 (commencing with Section 1797) of Health and Safety Code, in the discharge or attempt to discharge any duty of his or her office or employment, when no other punishment is prescribed, is punishable by a fine not exceeding one thousand dollars, or by imprisonment in a county jail not exceeding one year, or by both that fine and imprisonment.

◇ **407 PC Unlawful Assembly.**

Whenever two or more persons assemble together to do an unlawful act, or do a lawful act in a violent boisterous, or tumultuous manner, such assembly is an unlawful assembly.

◇ **409 PC Remaining After Warning to Disperse.**

Every person remaining present at the place of any riot, rout, or unlawful assembly, after the same has been lawfully warned to disperse, except public officials and person assisting them in attempting to disperse the same, is guilty of a misdemeanor.

◇ **415 PC Disturbing the Peace.**

Any of the following persons shall be punished by imprisonment in the county jail for a period of not more than 90 days, a fine of not more than four hundred dollars (\$400), or both such imprisonment and fine:
(1) Any person who unlawfully fights in a public place or challenges another person in a public place to fight.
(2) Any person who maliciously and willfully disturbs another person by loud and unreasonable noise.
(3) Any person who uses offensive words in a public place which are inherently likely to provoke an immediate violent reaction.

◇ **415.5 PC Disturbing the Peace of School Campus.**

(a) Any person who (1) unlawfully fights within any building or upon the grounds of any school, community college, university, or state university or challenges another person within any building or upon the grounds to fight, or (2) maliciously and willfully disturbs another person within any of these buildings or upon the grounds by loud and unreasonable noise, or (3) or uses offensive words within any of these buildings or upon the grounds which are inherently likely to provoke an immediate violent reaction is guilty of a misdemeanor punishable by a fine not exceeding four hundred dollars (\$400) or by imprisonment in the county jail for a period of not more than 90 days, or both.

◇ **602 PC Trespassing.**

Notwithstanding Section 602.8, every person who willfully commits a trespass by any of the following is guilty of a misdemeanor.

(k) Entering any lands, whether unenclosed or enclosed by fence for the purpose of injuring any property rights or with the intention of interfering with, obstructing, or injuring any lawful business or occupation carried on by the owner of the land, the owner's agent or by the person in lawful possession. (1) Entering and occupying real property or structures of any kind without the consent of the owner, the owner's agent, or the person in lawful possession.

◇ **626.4 PC Withdrawal of Consent to Remain on Campus.**

(a) The chief administrative officer of a campus or other facility of the university, or an officer or employee designated by the chief administrative officer to maintain order on such campus or facility, may notify a person that consent to remain on the campus or other facility under the control of the chief administrative officer has been withdrawn whenever there is reasonable cause to believe that such person has willfully disrupted the orderly operation of such campus or facility.

◇ **626.6 PC Disruption of College or University Campus.**

(a) If a person who is not a student, officer or employee of a university and who is not required by his or her employment to be on campus or any other facility owned, operated, or controlled by the governing board of that university, enters a campus or facility, and it reasonably appears to the chief administrative officer to maintain order on the campus or facility, that the person is committing any act likely to interfere with the peaceful conduct of the activities of the campus or facility, or has entered the campus or facility for the purpose of committing any such act, the chief administrative officer or his or her designee may direct the person to leave the campus or facility. If that person fails to do so or if the person willfully and knowingly reenters upon the campus or facility within seven days after being directed to leave, he or she is guilty of a misdemeanor.

◇ **647c PC Obstruction of Street, Sidewalk or Other Public Place.**

Every person who willfully and maliciously obstructs the free movement of any person on any street, sidewalk, or other public place or in any place open to the public is guilty of a misdemeanor.

FREEDOM of SPEECH

The University of California, Irvine recognizes the rights of individuals to engage in constitutionally protected free speech and public safety.

The UC Irvine Police Department also accepts responsibility to uphold and protect these rights as long as individuals conduct themselves in a reasonable manner.

When persons exercising these freedoms infringe on the rights of others, the activity loses constitutional protection and may in fact result in a violation of law or University policy.

The University, as awarded by the court, has the right to set its own set of codes and regulations governing the time, place, and manner for the exercise of free speech and public assembly.

These codes and regulations of the University of California, Irvine will be enforced by the UC Irvine Police Department, as necessary, and are described inside for your information.



University of California, Irvine Policies and Regulations

SPEECH AND ADVOCACY

The University has a special obligation to protect free inquiry and free expression. On University grounds open to the public generally, all persons may exercise the constitutionally protected rights of free expression, speech, and assembly. Such activities must not, however, interfere with the right of the University to conduct its affairs in an orderly manner and to maintain its property, nor may they interfere with the University's obligation to protect rights of all to teach, study, conduct business and fully exchange ideas. Physical force, the threat of force, or other coercive activities used to subject anyone to a speech of any kind is expressly forbidden.

TIME, PLACE, AND MANNER REGULATIONS

Orderly behavior and the normal conduct of University affairs shall govern time, place, and manner of exercising free speech and advocacy. Regard for the privacy of others shall be observed, and reasonable precautions shall be taken against practices which would make persons on campus involuntary audiences. Activities that are determined to pose a risk to personal safety, university property, or facility security will be rescheduled until such time that adequate and appropriate security can be made available, as determined by UCI Police Department. Refer to UCI Administrative Policies and Procedures Section 905.

AREAS FOR PUBLIC GATHERING

Specific areas and properties available for public meetings and gathering are made available through UCI Student Center and Event Services or appropriate scheduling office on a first-come, first-served basis.

AMPLIFICATION

Amplification may be used only at specified times and is prohibited at all other times and places. Guidelines for amplification and hours of use are available from the UCI Student Center and Event Services, or the appropriate scheduling office.

Summary of University Policies and State Law



No person on University property or at official University functions may:

- 1) Block entrances to or otherwise restrict the free flow of traffic into and out of campus buildings, parking lots, campus roads and walkways (sec.102.13, 102.15);
- 2) Obstruct or disrupt campus activities, classes, and offices (sec.102.13);
- 3) Block traffic or passage using tables or movable stands;
- 4) Use amplified sound without prior approval or utilize amplified sound that disrupts campus activities (sec.102.13);
- 5) Engage in physically abusive or threatening conduct toward any person (sec.102.08);
- 6) Exhibit disorderly or lewd conduct (sec.102.14);
- 7) Participate in a disturbance of the peace or unlawful assembly (sec.102.15);
- 8) Fail to comply with the directions of a University official acting in the performance of his or her duties (sec.102.16);
- 9) Engage in the theft, destruction of, or damage to any University property or equipment (sec.102.04);
- 10) Participants may video or audio record an event that is open to the public as long as it is in compliance with the UC Administrative Policies & Procedures Section 900-30, Policy on Filming and Photography on the UC Irvine campus.
